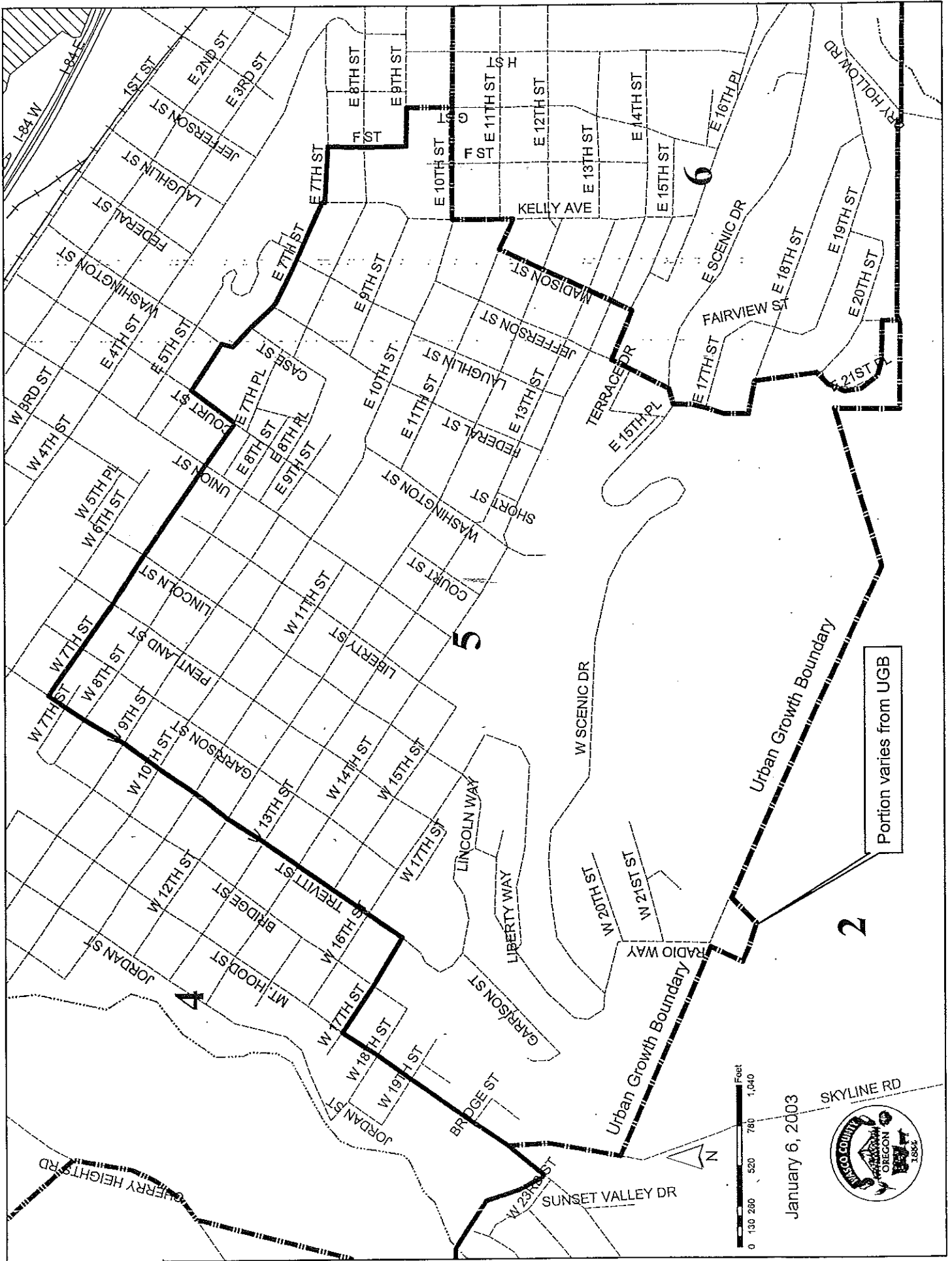
BOUNDARY DESCRIPTION – ZONE 5

NEW K-12 SCHOOL DISTRICT

WASCO COUNTY, OREGON

Beginning at a point where "G" Street intersects East 10th Street; Thence Westerly along East 10th Street to Kelly Avenue; Thence Southerly along Kelly Avenue to East 11th Street; Thence Northwesterly along East 11th Street to Madison Street; Thence Southwesterly along Madison Street to East 15th Street; Thence Northwesterly along East 15th Street to Jefferson Street; Thence Southwesterly along Jefferson Street to East Scenic Drive; Thence Westerly along East Scenic Drive to Jefferson Street; Thence Southerly along Jefferson Street to East 18th Street; Thence Southeasterly along East 18th Street to East 20th Street; Thence Southeasterly along East 20th Street to East 21st Place; Thence Southerly and Easterly along East 21st Place to Fairview Ave.; Thence Southerly along Fairview Ave. to the South line of W. D. Bigelow D.L.C. No. 40; Thence West along said South line of Bigelow D.L.C. to the Southwest corner of Bigelow D.L.C.; Thence North 33° 07' 30" East 697 feet to the Southeast corner of Ft. Dalles Military Reservation; Thence North 66° 34' West along said Reservation line 1227 feet to the Southeast corner of Brock's Addition to City of The Dalles; Thence South 47° 27' West 228.6 feet; Thence North 67° West 145 feet; Thence North 60° 22' 30" West 100 feet; Thence North 23° 37' 30" East 230 feet to a point on the Southerly line of Ft. Dalles Military Reservation and the Westerly right of way line of Radio Way; Thence North 66° 32' West to Skyline County Road; Thence Northerly along Skyline County Road to its intersection with Mt. Hood Street; Thence Northeasterly along Mt. Hood Street to West 17<sup>th</sup> Street; Thence Southeasterly along West 17<sup>th</sup> Street to Trevitt Street; Thence Northeasterly along Trevitt Street to West 7th Street; Thence Southeasterly along West 7th Street to Court Street; Thence Northeasterly along Court Street to West 6th Street; Thence Southeasterly along West 6th Street to Washington Street; Thence Southwesterly along Washington Street to East 7th Street; Thence Southeasterly along East 7<sup>th</sup> Street to "F" Street; Thence Southerly along "F" Street to East 9<sup>th</sup> Street; Thence Easterly along East 9<sup>th</sup> Street to "G" Street; Thence Southerly along "G" Street to East 10th Street, the beginning point of Zone 5.
