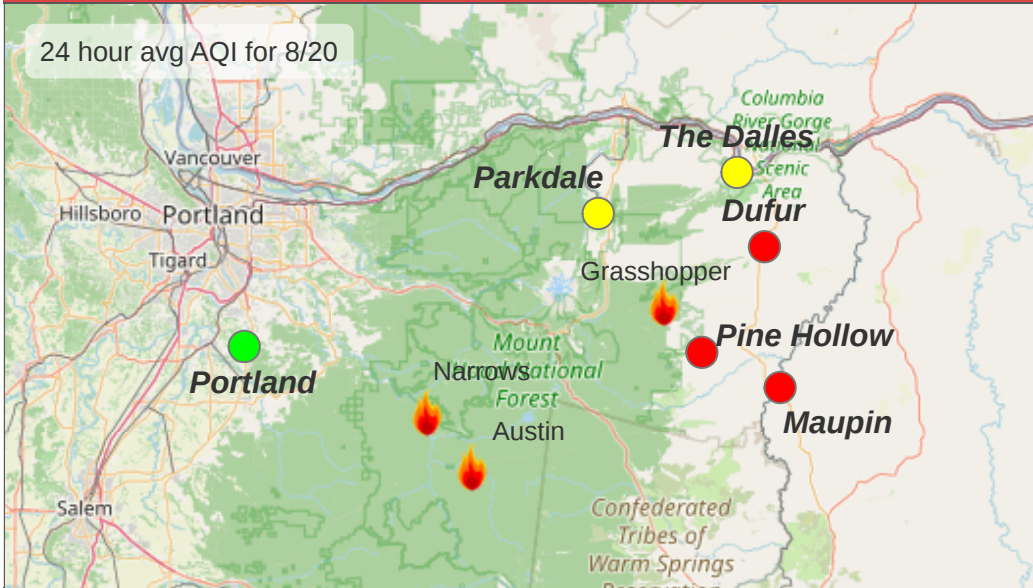

FIRE

The [Grasshopper](#) fire is currently estimated at 92,456 acres and is 66% contained. Fire activity for the [Grasshopper](#) fire is expected to remain active. The [Austin](#) fire is currently estimated at 3,760 acres and is 0% contained. Fire activity for the [Austin](#) fire is expected to remain active. The Narrows fire is currently estimated at 174 acres and is 0% contained. Fire activity for the Narrows fire is expected to remain active.

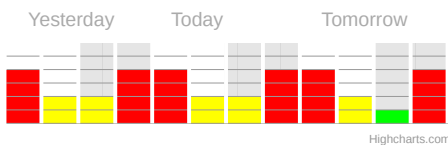
SMOKE

Smoke from the Grasshopper will continue to impact the communities closest to the fire, including Dufur, Pine Hollow, Wamic, Tygh Valley, and Maupin. These areas can expect to see VERY UNHEALTHY to HAZARDOUS AQI for several hours this morning before improving to MODERATE this afternoon and evening, with smoke returning tonight. Parkdale will see a similar pattern, but should remain at or below UNHEALTHY. Impacts in the larger area, including Portland, Hood River, and The Dalles should remain minimal, with levels staying between GOOD and MODERATE. Smoke from the Austin and Narrows fires may creep down into the Estacada area overnight, but AQI should remain at GOOD to MODERATE.

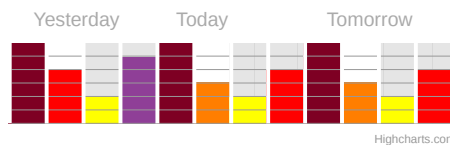
Most of the smoke from the Austin and Narrows fires will continue drifting to the southeast through the Warm Springs Reservation into Central Oregon. More info may be found in the [Central Oregon Smoke Outlook](#) for these locations.

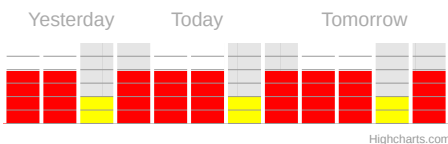
Parkdale Similar to yesterday.



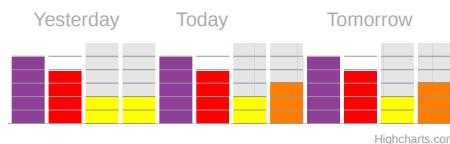
Dufur HAZARDOUS AQI in the morning, recovering in the afternoon and evening.



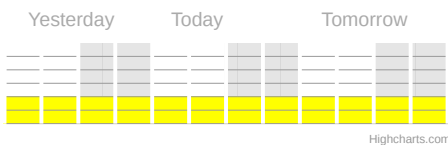
Pine Hollow Heavy smoke in the morning and overnight. Improving in the afternoon.



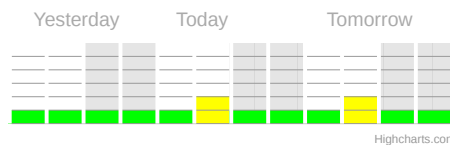
Maupin Heavy smoke in the morning; Air Quality improving through the day.

AIR QUALITY INDEX (AQI)

	Hazardous (H)	Everyone should avoid any outdoor activity
	Very Unhealthy (VU)	Everyone should avoid all physical outdoor activity
	Unhealthy (U)	People within Sensitive Groups should avoid all physical activity
	Unhealthy for Sensitive Groups (USG)	People within Sensitive Groups should reduce prolonged or heavy exertion
	Moderate (M)	Unusually sensitive individuals should consider limiting prolonged or heavy exertion
	Good (G)	None
